8.2. EXPOSURE CONTROLS:

ENGINEERING MEASURES: Comply with standard precautionary measures for working with chemicals. See Directive 2004/37/EG on the protection of workers from the risks related to exposure to carcinogens or mutagens at work. **HYGIENIC MEASURES:** When using do not eat, drink or smoke.

GENERAL PROTECTIVE AND HYGIENIC MEASURES:	Avoid contact with the eyes. Wash hands during work breaks and at the end of the shift. Provide skin protection plan.
RESPIRATORY PROTECTION:	Avoid excessive inhalation of concentrated vapors. Ensure adequate ventilation. If workers are exposed to high concentrations, they must use appropriate, certified respirators. Wear suitable respiratory protection in case of large scale exposure.
